Richard Shaull Award Application Guidelines

We are pleased to learn of your interest in applying for the Richard Shaull Award of Bryn Mawr Presbyterian Church. This <u>one-time award</u> is designed to fund new mission undertakings and/or to provide support for remarkable mission leaders. To qualify, proposals must fall into the categories of justice or transformational ministry. It may be designated for salaries (of a project or a remarkable individual doing Kingdom work), buildings, sabbaticals, study, service programs, travel and other uses that promote the mission and ministry of Christ's Church in the world. This award requires a final report to be submitted to BMPC, including both financial accounting and programmatic narratives.

Proposals will be evaluated using the following criteria, which are meant to be broadly interpreted and inclusive, not a rigid checklist.

- a. Justice or transformational ministry.
- b. Sustainable.
- c. Evangelical in the broadest sense.
- d. Empowering.
- e. Partnership rather than paternal.
- f. Respectful of the culture(s) in which it operates.
- g. Financially transparent and accountable.

The deadline for 2018 applications is Dec. 1, 2017. The Worldwide Ministries Committee will meet to review applications and present their recommendation to the Session of BMPC for its endorsement. Funding decisions will be made in the spring.

Richard Shaull Grant Criteria – Helpful Information to Consider

The following are the criteria that the Worldwide Ministries Council will use to evaluate applications. Please note that these criteria are meant to be broadly interpreted, and are not a rigid checklist.

The Shaull Award in particular seeks to promote Justice and Transformational Ministries

- **Justice** develops relationships with partner communities and with them identifies and seeks to overcome causes of needs and injustice. It involves activities that enable greater freedom and independence on the part of the recipients.
- **Transformation** in solidarity with partner communities and members, seeks humane community development and just structures and systems. It connotes a reciprocal relationship where both parties become interdependent and benefit from the relationship.

Worldwide Ministries at Bryn Mawr Presbyterian Church is in all its grant programs, broadly focuses on programs that connect faith and life by:

- Responding to immediate and future needs of others by provision of goods, services and training (ministries of compassion).
- Directly addressing a cause(s) or injustice(s) of immediate need (ministries of justice).
- Collaborating with other community organizations, whether they are faith communities or service organizations. We are especially interested in collaboration that crosses traditional boundaries such as religion, ethnicity, or class.

Additionally, we are looking for programs that do the following:

Engage Community.

We seek to support programs that (1) engage the community in program implementation and (2) focus on community assets (not perceived deficits). The community knows best what its needs are and what expectations are realistic. Therefore, there should be evidence of the served community's involvement as well as a clear understanding of the community being served, what its assets are, and what it needs to be successful.

Build Self-Sufficiency

We seek to support programs that foster self-sufficiency and empowerment, rather than teaching dependence.

Self-evaluate Using Measurable Outcomes

We seek to support programs that are focused on measurable outcomes; i.e., clearly defined means of assessing success.

Practice Accountability

We seek to support programs that are financially responsible and transparent.
